RE: ORC WEEKLY UPDATE

Wahcheeyay, Aanii, Boozhoo, She:kon, Shekoli,

As we approach the long holiday weekend, I am please to report that the rate of infection has plateaued for the last four days. Some communities are impacted more severely than others and I ask you to continue sending your prayers for all communities. Together we are working towards finding solutions that will support the specific needs of our communities and members.

The work in my office continues to be guided by the higher purpose of preserving and protecting the health, well-being and lives of First Nation Members during the COVID-19 pandemic, with an overall goal of zero new confirmed COVID-19 cases in First Nation communities. This weekly memo highlights our work.

COVID-19 CASES AND PREVENTION

COVID-19 CASES:

- Globally = 4,508,663
- Canada = 72.536
- Ontario = 21,494

COVID-19 First Nations in Ontario:

- Total Confirmed = 81 (44 on-reserve)
- Declared State of Emergencies = 70
- Self-Isolating Communities = 47
- Airport Restrictions = 12
- Road Restrictions = 76

PROVINCIAL MEASURES RESPONDING TO COVID-19

• Extended the Declaration of Emergency to June 2nd and have launched stage one of opening the economy.

FEDERAL MEASURES RESPONDING TO COVID-19

- ISC/FNIHB released a framework to assist First Nation's on re-opening their communities. The framework can be found at www.coo-covid19.com.
- Announced new measures to support large and middle-sized businesses and introduced additional measures to support seniors.

• ISC has begun transporting essential service personnel and supplies via carefully managed charter flights.

ORC OFFICE PANDEMIC INITIATIVES

My office is in the process of hiring a Director of Policy (COVID-19) and we continue
to work on the following initiatives: COVID-19 Community Coordinators; 24-Hour
Coordinated Response STAT Teams; and Community House Mapping (to support
tracing of contacts).

EMERGING ISSUES

- The Attorney General of Ontario Doug Downey joined First Nation leaders on Thursday May 14, 2020 to discuss the issue of enforcing and prosecuting First Nation by-laws.
 - A meeting with federal and provincial counterparts is being sought to resolve the issue of Bylaws, BCRs and Enforcement & Prosecution (Ontario Attorney General & Minister of Justice and Attorney General Canada).
- The Public Prosecution Service of Canada (PPSC) will prosecute by-laws related to COVID-19 and that are pursuant to the *Indian Act*.
